Evaluation (points)	Explanation
4	In the context of the criterion being evaluated, the study programme is at an excellent level. Still even at this highest level, several minor deficiencies may be observed in the context of the criterion evaluated, but no major improvement is required to eliminate such deficiencies.
3	In the context of the criterion being evaluated, the study programme is at a good level and meets all of the requirements, with its strengths prevailing and no material weaknesses observed. All the deficiencies discovered during the evaluation can be eliminated easily.
